- INTRODUCTION

The evaluation of the quality of project management was carried out in the period between October 8th and October 15th, 2021, in accordance with the procedure stipulated in PQA Guide. The questionnaire was completed by 50 out of 85 participants (58,8%).

FINDINGS

- 1. To what extent are you satisfied with the overall management of the KEY project so far?

Comments:

- All tasks and activities foreseen through the work packages have been implemented in a timely manner, and they are on line with the planned and desired quality criteria.
- The project is managed quite well, and the coordinator invested additional efforts to compensate for the activities and managing tasks which have suffered as a result of COVID19.
- It would be good if we had more coordination meetings to clarify some points of doubt as to upcoming tasks and reports.
- I am mostly satisfied with the way in which the project has been handled so far, bearing in mind the circumstances and difficulties resulting from the previous period which has largely affected the normal project implementation.
- It would be good if the communication was faster and more efficient.
- I am quite satisfied, bearing in mind the external factors which have largely affected the regular project implementation.
- 2. What are you particularly satisfied with and what would you like to highlight?
 - Partners are well aware of their responsibilities and we function as a team.
 - I like the fact that we can always contact the project coordinator and receive clear and valuable feedback.

 - It would be good if we were better synchronized when some of the tasks are performed jointly or depend on simultaneous completion of individual tasks.
 - Following the mutual agreement that we reach during online and face-to face meetings with regards to deadlines.
 - Everything is great.

Comment:

CONCLUSIONS & RECOMMENDATIONS

According to the respondents' feedback, one can assert that the project team is highly satisfied with the manner in which the project has been managed so far. Information and instructions are clear and they are delivered in a consistent and timely manner. The Committee justifies its role as a proper crisis and conflict management body and the project team is well-coordinated and cooperates in a friendly atmosphere.

The respondents are generally satisfied with the project atmosphere, as well as with the efficiency and efficacy of project implementation.

What is perceived as a main risk is still the pandemic of COVID19, as well as structural changes which occurred in partner institutions since the project inception.

Respondents would also recommend a more frequent communication, especially after the period of COVID.
